PJ	Participating Jurisdiction. In the context of the HUD HOME Program, it is a state or unit of general local government that has been approved by HUD to receive and administer HOME funds to implement a local housing strategy. PJs are responsible for developing a multi-year Consolidated Plan, matching federal HOME funds with their own resources and carrying out eligible activities like housing rehabilitation, new construction and tenant based rental assistance while adhering to HUD's regulations/agreements.
PH	Permanent Housing (can include PSH and RRH projects under HUD)
POC	Plan of Care

PSH	Permanent Supportive Housing
RAFT	Residential Assistance for Families in Transition (MA)
RFP	Request for Proposals. Used to solicit proposals for contracts under the negotiated procurement method.
RFQ	Request for Quotations. Used to solicit specific price proposals.

RRH	Rapid ReHousing project under either ESG or CoC programs. Rapid ReHousing is a primary solution for ending homelessness and has been demonstrated to be effective in getting people experiencing homelessness into permanent housing and keeping them there.
Section 8	Refers to the Housing Choice Voucher Program—a federally funded initiative that provides rent subsidies to low-income families, the elderly and people with disabilities to rent private marking housing. (Established through the Housing and Community Development Act of 1974)
Section 202	HUD program for Supportive Housing for the Elderly to expand the supply of affordable housing with supportive services for the elderly. Targets very low income seniors age 62+.
Section 202/811	Programs for housing assistance to the elderly <i>and</i> people with disabilities. Now two distinct programs but previously bundled together for development of housing <i>(ex. Melville Towers in New Bedford MA)</i> .
Section 811	HUD Program established by the National Affordable Housing Act of 1990 serves very low income persons with disabilities.
SFS	Southeast Family Services, Inc
SOAP	Structured Outpatient Addiction Program
SRO	Single-Room Occupancy. Under Section 221(d) program mortgage insurance is available for single room projects.
SSA	Social Security Administration
SSDI	Supplemental Security Disability Income

START	Stimulant Treatment and Recovery Team
Super NOFA	HUD's consolidated approach to issuance of Notices of Funding Availability.
