OBJECTIVE RANKING SELECTION PROCESS and PUBLIC AVAILABILITY

May 16.2024, June 20.2024 and July 18.2024	Public Announcements made during CoC meetings asking those interested in new project opportunities and/or DV Bonus projects for the coming CoC Competition round to contact the Collaborative Applicant (City of New Bedford's Office of Housing and Community Development OHCD).
July 31.2024	HUD releases the 2024 NOFO.
August 1.2024	The City of New Bedford's Office of Housing and Community Development (OHCD) issues an informational email blast and a Facebook post announcing the 2024 NOFO, the Competition Timeline, the forthcoming application availability and an invitation to any in the community that may wish to apply to contact the OHCD, directly.
August 10.2024	The OHCD as the CoC Collaborative Applicant publicly posts on the Continuum's website at https://www.bristolcountycoc.com and at https://www.newbedford-ma.gov/housing-community-development/ and issues RFPs for Renewals, New Projects and DV Bonus Projects
August 30.2024	The deadline date by which local Renewal, New and Bonus Project proposals are to be submitted to the City of New Bedford's OHCD by 12.00 noon. <i>(Per HUD, this deadline is no later than 30 days before the October 30.2024 Application Deadline.)</i>
September 2-6.2024	<ul style="list-style-type: none"> ▪ OHCD completes initial Threshold Reviews for all proposals received. ▪ Performance Review Committee Meeting undertakes Project Review for consideration of project performance for renewal applications and proposed new and bonus projects (if applicable) resulting in a proposed ranking for the BC CoC September meeting.
September 19.2024	BC CoC Meeting to review and approve Performance Review Committee recommendations for new projects, renewal projects and priority rankings.
September 20.2024	<ul style="list-style-type: none"> ▪ The 2024 Ranking and Selection Results posted on HSPN website at www.bristolcountycoc.com. <i>(Per HUD, this deadline is at least 15 days before the September 30.2024 Application Deadline.)</i> ▪ Notice of results, both for accepted/ranked projects and for any rejected or reduced projects, sent to project applicants in writing. <i>(Per HUD, this deadline is at least 15 days before the October 30.2024 Application Deadline.)</i>
September 27.2024	Appeals due to OHCD by 12.00pm. <i>(Agencies that have appealed will be notified in writing a minimum of 15 days prior to the October 30.2024 application deadline.)</i>
September 30.2024	Deadline for all ranked projects to submit a PDF file to the OHCD of their <i>esnaps</i> application by 12.00 noon.
October 7.2024	OHCD contacts project applicants with any corrections for final submission.
October 14.2024	Applicants submit final PDF file of their <i>esnaps</i> applications by 12.00 noon.
October 21.2024	<ul style="list-style-type: none"> ▪ <u>Target date for Completion of Draft Collaborative Application.</u> Collaborative Application, Project Listing and Project Applications are complete and entered into <i>esnaps</i> (though not submitted yet). ▪ A copy of all submission materials is posted on the CoC website at https://www.bristolcountycoc.com for public comment. <i>(Per HUD, this deadline is at least 2 days before the October 30.2024 Application Deadline.)</i> ▪ Community Members, Stakeholders notified of its availability for public comment.
October 24.2024	<u>Local Target Date for Submission of Collaborative Application.</u> Incorporate any changes necessitated from public comments and submit in <i>esnaps</i> . <i>(Per HUD, these materials are posted on the website two days before application submission).</i>
October 30.2024	HUD Deadline at 8.00pm for receipt of all Collaborative Applications and any Solo Applicant Submissions.
